L. Summary of my Activities and Future Plans -Academic Profile

My professional life combines three mutually stimulating and enriching spheres: research, clinical work and teaching, the latter based on and augmented by the knowledge and experience accumulated in the first two. My main field of interest and expertise is family relationships: couples, parenting, parent-child relations and children at risk in their families.

My clinical experience as a contributing factor to my research work

My clinical work at the Children and Adolescents Clinic, Geha Mental Health Center is both a source of scientific hypotheses, and a rich and diverse field for carrying out research. My clinical work promotes insights to the modes parents employ for coping with their children's psychiatric diagnoses and has led to further research in various topics which reflect my scientific pursuits and quality of work:

 Parental coping with a child diagnosed with ADHD (attention deficit disorder) which were published in *Child Psychiatry and Human Development*, 2006 (#26), and in *Research in Developmental Disabilities*, 2011 (#31).

- Youth with Conduct Disorders, published in 2011 in *Children and Youth Services Review* (#32).
- Adolescents with learning disabilities who were exposed to terror attacks, published in 2006 in *Comprehensive Psychiatry* (#24). The publication of this article led to an invitation to write the entry "Vulnerability for learning disorders" in the *Encyclopedia of the Sciences of Learning*.
- Adolescents with eating disorders, published in 2009 in *Eating Disorders: The Journal of Treatment & Prevention* (#28).
- Clinical work with several children raised by their grandparents (due to the death of their parent/s) has exposed me to the unique experiences attributed to grandparent-grandchild relationships, and led to the presentation of a paper at the 2nd International Congress for Psychoanalytic Family Therapy held in Montreal (2006).

Professional recognition

- For the past twenty years I have headed a multi-professional team for court expert testimony (in matters of child abuse, child custody and parental capacity, and guardianship) in the Children and Adolescents Clinic at the Geha Mental Health Center.
- My clinical, research and teaching experience in the field of psychiatric mental health led to an invitation to lead the committee in charge of writing and publishing the book *Social Work Expertise in Mental Health*. I edited and wrote a great part of this text-book, which covers the theoretical, empirical and interventional knowledge relevant to certified mental health social work experts. Since 2007 I have been serving as chairman of the Social Worker's Union Certification Committee for Social Work Expertise in Mental Health.
- I served for several years as an active member on the National Committee for Mental Health, a committee engaged in recommending the Health Department's policy regarding mental health.
- My membership in the Statutory Ethics Committee at Geha Mental Health Center promoted insight to the conflict that arises between the Patient's Rights Law (1996) and the legal status of the psychiatric patient's family, and led me to write the article "The application of the Patient's Rights Law in psychiatry", published in the Israeli Medical Journal *Harefua*.
- My expertise in the field of child abuse and neglect has led to invitations to lecture in various workshops on the topic (e.g., at The Institute of Legal Training for Attorneys and Legal

Advisers), and to appoint me as reviewer of research grant proposals, as well as doctoral dissertations and manuscripts for academic journals.

- •I gave (2004-2008) an annual lecture on child abuse and neglect to medical students in the New York program at the School of Medicine, Tel-Aviv University.
- My knowledge and experience in the diagnosis and treatment of children at risk in their families have also led to many requests for interviews in the media (television and newspapers).
- I have developed and organized a two-year program for the certification of couple and family therapists in the Continuing Education Unit at the Bar Ilan School of Social Work. This prestigious program has been running for seventeen years, and registration applications increase every year.

Research

The cornerstone of my thinking is Attachment Theory, which inspires the methodological, theoretical, and empirical aspects of my academic activities as follows:

Research studies and publication in the field of child abuse

In my doctoral dissertation I developed a new unique questionnaire for the examination of attachment style in children that did not exist before. The questionnaire has received international acclaim and was published on the National Child Traumatic Stress Network (NCTSN) web-site. It was also recommended for use by researchers studying child abuse under Dr. John Briere, one of the most well known researchers in the field of child abuse, and Director of Psychological Trauma Program at the University of Southern California,

In view of the Attachment Theory perspective I studied the consequences of childhood abuse and neglect on their development. The results of these studies were published in the following journals:

Research studies and publication in the field of divorce process

- One of the most common risk-factors for children is high-conflict divorce. My study examining parenthood in the midst of the divorce process (with my colleague the deceased Prof. Orna Cohen) was awarded a grant by the Ministry of Social Affairs and Social Services; its results were published in *Contemporarily Family Therapy* (2005) (#22); *Journal of Divorce and Remarriage* (2012) (#34); *Journal of Social and Personal Relationships* (2013) (#36); *Journal of Child and Family studies* (2014) (#37); *Marriage and Family Review* (2014) (#39).
- My "Guidelines for visitations arrangements of the non-custodial parents and their infant" (published in *Journal of Divorce and Remarriage*, 2002; #15) are referred to daily by Social Welfare Officers.
- An article examining the experience of alienated mothers was published in *Child & Family Social Work* in 2012 (#33).
- Divorced custodial fathers whose children reside with them and who have sole rights and responsibility for child rearing, constitute a rapidly growing group of single parents. In collaboration with the deceased Prof. Orna Cohen a research proposal on this subject was awarded a grant for three years by the Israel Science Foundation (34,000\$ per year). The results of this study were published in *Family Relations* (2014 (#41); *Family Process* (2016) (#43); *Marriage and Family Review* (2017 (#47); *Psychology of Men & Masculinity* (*2018) (#53).
- The interest in study paternal practice led me to examine fatherhood from different angles: the paternal practice of fathers to infants in comparing to fathers to adolescents (published in the book "*Handbook of the Psychology of Narcissism*", 2014); the paternal practice of fathers with mental illness (published in *Community Mental Health Journal*, 2016; #45);

Ultraorthodox Jews fathers (published in *Family Issues*, 2018, #51), and recently I submitted an manuscript studying the fatherhood of released prisoners.

Research studies and publication in the field of couple and family relations

- Being a member in the International Society for Interpersonal Acceptance and Rejection inspire me to study parent-children relations and their impact on adulthood, I present my studies in the conferences, and some of my presentations were accepted for publication as chapters in the conference books.
- A study examining young adults' romantic relationships was presented at the 2nd Conference of the International Society for Interpersonal Acceptance and Rejection, and was published in the book of selected studies presented at this conference.
- The emotional experiences of children in small and large families was presented at the 3rd Conference of the International Society for Interpersonal Acceptance and Rejection (2010), and was also published as a chapter in the 3rd book of ISIPAR Conference of selected studies presented at this conference.
- From the attachment theory perspective, I have recently studied the manifestations of caregiving characteristics in parental behavior and affects. The studies mentioned above on fatherhood examined fathers' caregiving behaviour and, more recently, my study comparing the caregiving dispositions of married and divorce custodial fathers and mothers was published in *Marriage and Family Review* (2018) (#54).
- Being chairman of the Social Worker's Union Certification Committee for Social Work Expertise in Mental Health led me to examine how compassion fatigue spillover into the marriage life and the results of the study were published in *Journal of Social Service Research* (2016) (#46) and in *Traumatology* (2018) (#49).

Future plans

 As head of the MA program at the School of Social Work, Sapir Academic College, I supervise students working on their final assignments, and initiate the subject of their presentations on various aspects of parenting, such as parenting under fire or parental personality characteristics and their impact on children's self-perception.

- I have recently begun to explore parental caregiving, an aspect of attachment theory that is now gaining some scholarly attention. I explore parental caregiving and reflection in predicting children adjustment in stressful situation.
- I'm in the process of writing two articles portraying the impact of couple caregiving and intimate relations on their marriage satisfaction from dyadic model (by APIM).
