## **G. Summary of my Activities and Future Plans**

My academic journey has centered on tort law, public authority liability, and regulatory negligence. I have focused on how these legal frameworks can promote economic efficiency, justice, and accountability. Over the past decade, I have explored the intersection of tort law and administrative law, developing new insights into how these legal regimes interact to shape public policy and institutional behavior.

Looking ahead, my research will focus on three main areas that are essential to the development of tort law in the 21st century:

- **Public Authority Liability in Evolving Regulatory Contexts:**

With the rapid development of technology and public governance, traditional liability frameworks are increasingly challenged by new forms of risk and regulatory oversight. I intend to explore how tort law can be adapted to address liability issues in digital governance, artificial intelligence, and public health emergencies. This study will propose a new framework for assessing the accountability of public authorities in these dynamic areas, balancing the need for innovation with the protection of individual rights.

- **Integrating Tort Law with Administrative Law:**

Integrating tort law principles with administrative doctrines such as reasonableness, proportionality, and discretion is a pressing issue in modern legal research. My future research will focus on developing a comprehensive model that clarifies the boundaries and synergies between these areas of law, emphasizing improving efficiency in the public sector and protecting civil rights. This work will contribute to a broader understanding of how legal accountability can enhance public trust and institutional legitimacy.

- **Tort Law as a Tool for Combating Global Threats:**

In an era characterized by global challenges such as terrorism, climate change, and pandemics, tort law can be a powerful tool for compensation and deterrence. Building on my forthcoming publication, *Law Tort as a Remedy for Terrorism* (Touro Law Review, 2025), I plan to expand my research on using tort law to address transnational threats. This includes examining the role of international cooperation and comparative legal analysis in developing effective legal responses to these issues.

A significant milestone in my academic career will be my tenure as a visiting scholar at Berkeley Law School during the 2025–2026 academic year. This prestigious appointment will allow me to collaborate with leading scholars and policymakers in tort and administrative law. I aspire to engage in comparative research examining how different legal systems address public accountability, focusing on the United States and Europe.

During this time, I intend to initiate a collaborative research project on the secondary use of legal information to improve public service delivery and advance justice.

This project will involve interdisciplinary collaboration with experts in law, data science, and public policy to develop practical recommendations for increasing the transparency and efficiency of public service institutions. In conclusion, my future research will combine legal theory from tort law and administrative law with practical solutions that address real-world challenges. Through teaching, research, and international collaboration, I aim to advance emerging fields of law and harness them to develop just, efficient, and effective legal systems.
