L. Summary of my Activities and Future Plans

1. <u>Publications</u>

Jewish and International law

My dissertation (2012) analyzed the attitudes of Jewish law to public international law 1907-2007. In the last four years I have published four articles, two in collaboration with another scholar, based on the three rabbis discussed in the first chapter of the dissertation. One article received the prestigious Cegla prize for the best student article 2011. As well, I published an article which utilizes the methodology and background of the dissertation, and applies it to the problem of endangering soldiers in order to prevent danger from enemy civilians. This article received the Rabbi Saul Israeli prize for best article in Torah scholarship of Eretz Hemda institute, 2014.

More general applications of my research – to the interrelations of religions and international law have been published in the European review of history (reprinted in a book about globalism), and an article about empowerment published (2016) in a book about religion and empowerment.

Goals: To publish a book regarding Jewish legal coping with international law, with sources (as an E-book) in Hebrew, and shorter in English.

Methodology of Jewish law

I co-edited a book (with Prof. Christine Hayes from Yale) titled *The interaction of Jewish and other legal systems* (2014). Over the years I wrote 6 articles on methodology of Jewish law. I discussed pluralism within Jewish law; Jewish law and space (published in Italian); Jewish law and borders (co-authored with Tami Arieli, a political geographer); Jewish law and social cognition, Interaction of Jewish law with other legal systems – including structural and system analysis; and an article which discusses the importance of deliberation and choice to the development and integrity of Jewish law.

Goal: To publish a book or collection of Articles on "new methodologies in Jewish legal research".

Digital (Jewish) Legal studies

I've been promoting the implementation of Digital humanities to Jewish law and to legal studies. In both areas research is limited by the unavailability of open legal data. I participated in efforts to open the data and started co-operations to prepare numerous research projects as data will become available.

<u>Goal</u>: Establish an Israeli legal database and lay the infrastructure for a research center for digital study of Israeli law.

Social Action Research

As a Feminist religious activist, some of my research is connected to social issues like the status of women, the social construction of males in the Jewish legal culture, rape and social justice. My research concerning torture is also connected to this concern.
